BAC DECISION NO. 47-11-2023

WHEREAS, there is an approved Purchase Request (PR) No. CDO-2023-10-0054, dated 10 October 2023 by the Deputy Ombudsman for Mindanao Anderson A. Lo with an estimated cost of Eighty-Four Thousand Pesos (₱84,000.00), for the procurement of six (6) units Steel Filing Cabinets for the Office of the Deputy Ombudsman-Cagayan de Oro City Regional office.

WHEREAS, under BAC Resolution No. 71, series of 2023, dated 11th of October 2023, which was approved by the Head of the Procuring entity, the BAC recommended resorting to Small Value Procurement (Section 53.9) in procuring the six (6) units Steel Filing Cabinets as stated in PR No. CDO-2023-10-0054, dated 10 October 2023.

WHEREAS, the BAC, thru its Secretariat, distributed the Invitations or Request for Submission of Price Quotations to the suppliers of the said item and obtained three (3) price quotations from credible suppliers namely:

- 1.) JACKSONS' ENTERPRISES CORPORATION**
- 2.) DAVAO BASIC STEEL INDUSTRIES, INC.**
- 3.) STARBRIGHT OFFICE DEPOT, INC.**

WHEREAS, the BAC, after due deliberation of the received Request for Quotation from the suppliers finds that **DAVAO BASIC STEEL INDUSTRIES, INC.** and **STARBRIGHT OFFICE DEPOT, INC.** quoted the lowest and second lowest price but, failed to submit the required documents. **JACKSONS' ENTERPRISES CORPORATION** offered the third lowest price and compliant to the documents required for the project stated below:




