WHEREAS, there is an approved Purchase Request (PR) No. 23-10-0126, dated 18 October 2023, by the Deputy Ombudsman for Mindanao Anderson A. Lo, with an estimated cost of Sixty Thousand Pesos (₱60,000.00) for the labor and materials for the installation of eight (8) units Controller Smart Air-conditioner for the Server room and CCTV room of the Office of the Deputy Ombudsman for Mindanao use.

WHEREAS, under BAC Resolution No. 74, series of 2023, dated 18th of October 2023, which was approved by the Head of the Procuring entity, the BAC recommended to use the alternative method of procurement specifically, Small Value Procurement under Negotiated Procurement “(Section 53.9)” in procuring the labor and materials for the installation of eight (8) units Controller Smart Air-conditioner for the Server room and CCTV room of the Office of the Deputy Ombudsman for Mindanao as stated in PR No. 23-10-0126 dated October 18, 2023.

WHEREAS, the BAC, thru its Secretariat, distributed the Invitations or Requests for Submission of Price Quotations to suppliers on the said Purchase Request and had obtained three (3) price quotations from credible suppliers namely:

- 1.) AIRPROSYSTEMS, INC.
- 2.) ROMSAN REF-CON MARKETING & SERVICES, INC.
- 3.) GIZMO ETC ACCESSWHERE, INC.

WHEREAS, the BAC, after due deliberation of the received Request for Quotations (RFQ's) from the suppliers find that only **GIZMO ETC ACCESSWHERE, INC.** quoted the price and compliant to the documents required by the government for the procurement of labor and materials stated as follows:

for Mindanao






