**BAC DECISION NO. 52-11-2023**  
*Series of 2023*

**WHEREAS**, there is an approved Purchase Request (PR) No. 23-11-0130, dated 08 November 2023, by the Deputy Ombudsman for Mindanao Anderson A. Lo with an estimated budget cost of Seven Thousand Eight Hundred Pesos (₱7,800.00) for the procurement of labor and materials for the replacement of tires and other accessories of two (2) units Motorcycle with Plate No. SE-6249 and SE-6250 of the Office of the Deputy Ombudsman for Mindanao, Davao City.

**WHEREAS**, under BAC Resolution No. 80, series of 2023, dated 8<sup>th</sup> of November 2023, which was approved by the Head of the Procuring Entity, the BAC recommended to resort to Small Value Procurement (Section 53.9) in procuring the labor and materials for the replacement of tires and other accessories of two (2) units Motorcycles as stated in PR No. 23-11-0130 dated 08 November 2023.

**WHEREAS**, the BAC, thru its Secretariat, distributed the Invitations or Requests for Submission of Price Quotations to the suppliers of the said labor and materials and had obtained three (3) price quotations from credible suppliers namely:

- 1.) GERCA AUTO CARE AND SUPPLY
- 2.) C&M MOTOR PARTS AND SUPPLY
- 3.) GDB MOTOR PARTS AND PLUMBING SUPPLIES

**WHEREAS**, the BAC, after due deliberation of the received Request for Quotation from the suppliers find that **C&M MOTOR PARTS AND SUPPLY** offered the lowest quoted price, but, they are not compliant with the documents required because they are not PhilGEPS registered. **GERCA AUTO CARE AND SUPPLY**, quoted the second lowest price and compliant with the documents required by the government, which is most advantageous to the government for the procurement of labor and materials as stated below:

Labor and materials for the replacement of tires and other accessories of two (2) units Motorcycle with Plate No. SE-6249 and SE-6250.	<b>₱7,400.00</b>




