WHEREAS, there is an approved Purchase Request (PR) No. CDO-2023-10-0055, dated 16 October 2023, by the Deputy Ombudsman for Mindanao Anderson A. Lo with an estimated budget cost of Six Thousand Pesos (P6,000.00) for the procurement of supply and installation of one (1) unit Condenser Fan Motor for 3-ton floor-mounted Air-condition of the Office of the Deputy Ombudsman for Mindanao Regional Office, Cagayan de Oro City.

WHEREAS, under BAC Resolution No. 73, series of 2023, dated 16th of October 2023, which was approved by the Head of the Procuring Entity, the BAC recommended to resort to Small Value Procurement (Section 53.9) in procuring the supply and installation of one (1) unit Condenser Fan Motor for 3-ton floor-mounted Air-condition as stated in PR No. CDO-2023-10-0055 dated 16 October 2023.

WHEREAS, the BAC, thru its Secretariat, distributed the Invitations or Requests for Submission of Price Quotations to the suppliers of the said supply and installation and had obtained three (3) price quotations from credible suppliers namely:

WHEREAS, the BAC, after due deliberation of the received Request for Quotation from the suppliers find that **CLEANFIX REFRIGERATION AND AIRCONDITIONING SERVICES** offered the lowest quoted price and compliant with the documents required by the government, which is most advantageous to the government for the procurement of supply and installation as stated below:

Supply and installation of one (1) unit **P5,500.00**






