WHEREAS, there is an approved Purchase Request (PR) No. 23-10-0127, dated 18 October 2023, by the Deputy Ombudsman for Mindanao Anderson A. Lo with an estimated budget cost of Two Hundred Fifty Thousand Pesos (P250,000.00) for the procurement of Annual Preventive Maintenance & Diagnostic Services on a quarterly basis of various vehicles of the Office of the Deputy Ombudsman for Mindanao, Davao City.

WHEREAS, the BAC, thru its Secretariat, distributed the Invitations or Requests for Submission of Price Quotations to the suppliers of the said Annual Preventive Maintenance & Diagnostic Services and had obtained three (3) price quotations from credible suppliers namely:

- 2.) INVESTITURE CORP.
- 3.) GERCA AUTO CARE AND SUPPLY

WHEREAS, the BAC, after due deliberation of the received Request for Quotation from the suppliers find that **INVESTITURE CORP.** offered the lowest quoted price and compliant to the documents required by the government, which is most advantageous to the government for the Annual Preventive Maintenance & Diagnostic Services as stated below:


