- SAME PRICE QUOTATION: If two (2) or more suppliers submit the same price quotation and have been post-qualified as the suppliers with the Lowest Calculated Responsive Quotations, the Office of the Ombudsman shall adopt and employ "draw lots" as the tie breaking method to finally determine the single winning provider. - 3. PRICE ESCALATION. All bid prices for the given goods/items in the contract as awarded shall be considered as fixed prices, and therefore not subject to price escalation during contract implementation.
- 4. ALTERNATIVE BIDS/PRICE QUOTATIONS. Alternative Bids/Price Quotations shall be rejected.
