

# BIDS AND AWARDS COMMITTEE MERSOLUTION NO. PB-23-12, s. 2023

## RE: <u>AWARD</u> FOR LOTS 1 TO 6 AND DECLARATION OF <u>FAILURE</u> <u>OF BIDDING</u> FOR LOT 7 OF

PUBLIC BIDDING OF GENERAL OFFICE SUPPLIES AND TONERS/INKS/CARTRIDGES FOR PRINTER AND FACSIMILE MACHINES FOR THE OFFICE OF THE OMBUDSMAN (PB 2023-11)

WHEREAS, the Office of the Ombudsman has programmed and approved Purchase Request (PR) No. PU-23-07-123 dated 18 July 2023 for the procurement of General Office Supplies unavailable at the Procurement Service-Department of Budget and Management (PS-DBM) with a total Approved Budget for the Contract (ABC) of Eight Million Eight Hundred Forty-Seven Thousand Seven Hundred Seventy Pesos (P8,847,770.00);

WHEREAS, the Bids and Awards Committee-Main (BAC-Main), in an approved Memorandum dated 24 August 2023, was authorized to conduct its procurement through Public Bidding in accordance with the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184;

WHEREAS, a Pre-Procurement Conference<sup>1</sup> was conducted on October 06, 2023 with the Chairperson and Members of the BAC-Main, the Chairperson and Members of the Technical Working Group (TWG) and the members of the BAC Secretariat-Main in attendance;

WHEREAS, the Head of the Procuring Entity (HoPE), upon the recommendation of the BAC-Main and the TWG,<sup>2</sup> approved the technical specifications and total ABC of this procurement project at Eight Million Eight Hundred Forty-Seven Thousand Seventy Pesos (\$\mathbb{P}8,847,070.00);

WHEREAS, on 24 October 2023, the Invitation to Bid (ITB) for PB 2023-11: Public Bidding of General Office Supplies and Toner/Ink Cartridges for Printer and Facsimile Machines for the Office of the Ombudsman<sup>3</sup> was posted on the PhilGEPS website, Ombudsman website and OMB Bulletin Board;

**WHEREAS**, Letters of Invitation for the Pre-Bid Conference, Opening of Bids, Bid Evaluation and Post-Qualification were sent to and received by:

WHEREAS, on 08 November 2023 at 9:30 a.m., a Pre-Bid Conference<sup>4</sup> was conducted<sup>5</sup> with the BAC-Main, TWG, witnesses/observers and six (6) prospective bidders<sup>6</sup> in attendance;

WHEREAS, no Supplemental/Bid Bulletin No. 1 was issued for this procurement project;

WHEREAS, from 24 October 2023 to 21 November 2023, four (4) bidders<sup>7</sup> purchased and submitted the bidding documents before the 2:00 p.m. deadline on 21 November 2023;

WHEREAS, the Opening of Bids<sup>8</sup> was conducted on 22 November 2023 at 9:30 a.m. with the BAC-Main, the four (4) bidders<sup>9</sup>, the one (1) witness/observer, the members of the BAC Secretariat, and the members of the TWG in attendance;

WHEREAS, bid envelopes of ZG Marketing Corporation, Apex Office Supplies and Equipment Trading, Integrated Computer Systems, Inc. (ICSI) and Quartz Business Products Corporation were opened;

WHEREAS, after the conduct of eligibility check and evaluation of the submitted bids, 10 the BAC-Main, upon the recommendation of the TWG, rated all participating bidders as "ELIGIBLE" to participate further in the Opening of Bids in their respective lots, to wit;

WHEREAS, on 24 November 2023, a Notice of Post Qualification 13 was issued and ZG Marketing Corporation and ICSI were directed to submit/present, the original copies and certified true copies of the required documents to the TWG/BAC during the postqualification proceedings on 30 November 2023. Corollary thereto, witnesses and observers were likewise invited to attend the said activity;

WHEREAS, the TWG, in its Memoranda dated 05 December 2023 and 11 December 2023, recommended the following:

- 1) To declare ZG Marketing Corporation as the Single/Lowest Calculated and Responsive Bid for Lots 1, 2, 4, and 5;
- 2) To declare ICSI as the Lowest Calculated and Responsive Bid for Lot 3;
- 3) To declare ZG Marketing Corporation as Post-Disqualified for Lot 6 and 7 considering that it failed to submit certification/s indicating that it is an authorized dealer of Samsung and Fuji Xerox Products;
- 4) To conduct Post-Qualification proceedings on the ICSI, the 2<sup>nd</sup> Lowest Calculated Bidder for Lot 6;
- 5) To declare a failure of bidding for Lot 7 there being no other bidder which submitted a bid;14

WHEREAS, on 12 December 2023, the BAC, upon recommendation of the TWG issued a Notice of Post-Disqualification to ZG Marketing Corporation with respect to its bid for Lots 6 and 7;

WHEREAS, ZG Marketing Corporation did not file any Request for Reconsideration within three (3) calendar days from receipt of the said notification;

WHEREAS, on 12 December 2023, a Notice of Post Qualification<sup>15</sup> was issued to ICSI directing it to submit/present, the original copies and certified true copies of the required documents to the TWG/BAC during the post-qualification proceedings for Lot 6 on 18 December 2023. Corollary thereto, witnesses and observers were likewise invited to attend the said activity;

WHEREAS, the TWG, in its Memorandum dated 19 December 2023 and 05 January 2024 recommended to declare ICSI as the 2<sup>nd</sup> Lowest Calculated and Responsive Bid after having passed all the criteria for post-qualification for Lot 6;
