# CONTRACT AGREEMENT (CA No. 2024-06)

# KNOWN ALL MEN BY THESE PRESENT:

THIS AGREEMENT made this	 between:

PHILIPPINE GLOBAL COMMUNICATIONS, INC., with business address at 8755 PHILCOM Building, Paseo de Roxas, Makati City, represented by Ms. KRISTINE D. GAMBOA. Head, Business Development Group (hereinafter called "the SUPPLIER") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly PB2024-01: Public Bidding for the Dedicated/Leased Line Internet Connection for the Office of the Ombudsman and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Seven Hundred Six Thousand Six Hundred Fifty Six Pesos (P706,656.00) (hereinafter called "the Contract Price"), to wit:

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation:

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of SEVEN HUNDRED SIX THOUSAND SIX HUNDRED FIFTY-SIX (\$\frac{p}{706,656.00}\$) or such other sums as may be ascertained, PHILIPPINE GLOBAL COMMUNICATIONS, INC. agrees to the Supply, Delivery, Installation Dedicated/Leased Line Internet Connection for the Office of the Ombudsman in accordance with its Bid.
- 4. The **OFFICE OF THE OMBUDSMAN** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
