- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of FOUR MILLION THREE HUNDRED SIXTY-SIX THOUSAND TWO HUNDRED NINETY-NINE PESOS AND EIGHTY CENTAVOS (\$\frac{P}4,366,299.80) or such other sums as may be ascertained, ZG MARKETING CORPORATION agrees to the Public Bidding of General Office Supplies and Toner/Ink Cartridges for Printer and Facsimile Machines for the Office of the Ombudsman (Lots 1, 2, 4 and 5) in accordance with its Bid.
