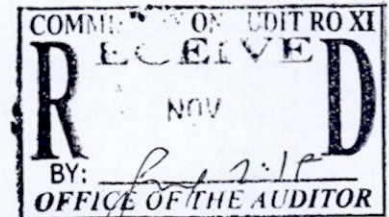


## FUEL SUPPLY AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:



This **FUEL SUPPLY AGREEMENT** (herein referred to as Agreement) is entered into and between **ZEDMEN ENTERPRISES**, a company duly organized and existing under the laws of the Philippines, with principal address at P3, NHA, Zone 5, Kauswagan, Cagayan de Oro City, and represented by its Manager, **IAN GIL G. MENDEZ**, hereinafter referred to as the **SUPPLIER**;

--and--

The **OFFICE OF THE DEPUTY OMBUDSMAN FOR MINDANAO-CAGAYAN DE ORO REGIONAL OFFICE**, with office address at Ground Floor, YMCA Bldg., #91 Julio Pacana St., Barangay 21, Cagayan de Oro City, represented by the Deputy Ombudsman for Mindanao, **ANDERSON A. LO**, hereinafter referred to as the **PURCHASER**, with official address at Earth corner Libra Street, GSIS Heights, Matina, Davao City;

WITNESSETH; That-

**WHEREAS**, the **SUPPLIER** is engaged in the business of supplying gasoline, diesoline, and other petroleum products (herein referred to as Fuel);

**WHEREAS**, the **PURCHASER** is an end user of the Fuel and has urgent demand for Fuel consumption; and

**WHEREAS**, the **PURCHASER** desires to purchase Fuel from the **SUPPLIER**, and the **SUPPLIER** desires to sell Fuel to the **PURCHASER**.

**NOW THEREFORE**, for and in consideration of the mutual covenant contained herein, the **SUPPLIER** agrees to supply Fuel, and the **PURCHASER** agrees to purchase Fuel, for one year, or twelve (12) months from OCT 01 2024 to SEP 30 2025 in consideration of the terms and conditions set forth below.

### TERMS AND CONDITION

- 1. PURPOSE.** By signing this Agreement, the **PURCHASER** relies upon the **SUPPLIER** to furnish the needed Fuel at competitive prices to meet its Fuel needs as indicated in Purchase Request (PR) No. 2024-06-0019 dated June 19, 2024.
- 2. RESPONSIBILITY OF THE PARTIES.** The **PURCHASER** shall pick-up the needed Fuel at the **SUPPLIER'S** gasoline station, presenting the officially signed Purchase Order to the representative/s of the **SUPPLIER** and the **SUPPLIER** shall serve the needed Fuel of the **PURCHASER**.
- 3. ANNUAL QUANTITY.** The **SUPPLIER** shall offer to supply and serve, and the **PURCHASER** shall purchase, One Thousand (1,000) liters of Diesel fuel and Two hundred fifty (250) liters of regular Gasoline fuel throughout the term of twelve (12)



months, with an Agreement price of **SEVENTY NINE THOUSAND FIVE HUNDRED PESOS (PhP 79,500.00)**.

4. **PRICES PER LITER.** Fuel prices per liter shall be based on the current market price.
5. **TYPES OF VEHICLES AND GENERATOR.** The withdrawal of the Fuel shall be intended for the generator set and official vehicles of the **PURCHASER**, to wit:

The **SUPPLIER** shall, however, provide Fuel to vehicle/s other than the type of vehicles and plate numbers enumerated in this contract, provided that the **PURCHASER** or his authorized representative shall submit a letter of accommodation for the inclusion of the additional official vehicle/s.

6. **PAYMENT.** The **SUPPLIER** shall submit an accurate Statement of Account together with the complete requirements/attachments to the **PURCHASER** on a monthly basis. Payment shall be made within sixty (60) days upon receipt of the foregoing documents, subject to the withholding of appropriate government taxes. Payment shall be made to the bank account of the **SUPPLIER** with **LAND BANK OF THE PHILIPPINES-Talibon, Bohol Branch**, under the name of **IAN GIL G. MENDEZ**, with Account Number 2232-0054-19.



7. **CANCELLATION OF AGREEMENT.** This Agreement is subject to cancellation by either party within thirty (30) days after acceptance of written notification, provided that such cancellation shall be without prejudice to the rights and obligations of both parties.
8. **EFFECTIVITY:** This agreement shall take effect on OCT 01 2024 up to SEP 30 2025. The PURCHASER may extend this Agreement on a monthly basis thereafter using the same terms and conditions stipulated under this Agreement.
