WHEREAS, by approved Purchase Request (PR) No. 2025-02-011 dated 4 February,¹ the Office initiated the procurement of *seven units EXECUTIVE CHAIRS, SENIOR, HIGH BACK W/ PADDED ARM RESTS*, with an estimated total cost of **₱84,000.00**;

WHEREAS, by BAC-For Alternative Methods of Procurement (BAC-AMP) Resolution No. 12, Series of 2025, dated 6 February 2025, the mode resorted to for this procurement is Negotiated Procurement, specifically Small Value Procurement, under Sections 53 and 53.9 of *The 2016 Revised Implementing Rules and Regulations*;

WHEREAS, the BAC-AMP, thru its Secretariat, distributed the Requests for Quotations (RFQs) to credible suppliers of the aforesaid service/s and goods; the BAC-AMP received the following price quotations:

WHEREAS, the Abstract of Bid/Canvass shows that Prince Educational Supply quoted the lowest price; however, it did not submit the complete documentary requirements (Notarized Omnibus Sworn Statement). Savecon Trading, on the other hand, quoted the second lowest price but did not submit the documentary requirements. GH Max Corporation quoted the third lowest price but its submission also lacked one of the documentary requirements (Notarized Omnibus Sworn Statement). Trust Hardware Phils., Inc. quoted the fourth lowest price, which is within the Approved Budget for the Contract (ABC) of this procurement of PhP84,000.00 and submitted the complete documentary requirements. Meanwhile, DDIS Inc. quoted the highest price and did not submit the documentary requirements.

WHEREFORE, in view of the foregoing, the BAC-AMP recommends that:
