WHEREAS, on 25 October 2024, the Bids and Awards Committee for the Alternative Methods of Procurement (BAC-AMP) of the Office of the Ombudsman, Area Office for Mindanao (OMB-Mindanao), through the BAC-AMP Secretariat, received Purchase Request (PR) No. CDO-2024-10-0039 dated 21 October 2024,<sup>1</sup> for the *Procurement of Furniture of the Office of the Ombudsman, Cagayan de Oro Regional Office*, specifically:

*Purpose: For the replacement of damaged or dilapidated furniture of the Office of the Ombudsman, Cagayan de Oro Office.*

WHEREAS, the aforesaid procurement is indicated in OMB-Mindanao Annual Procurement Plan (APP) for Calendar Year 2024 *Item No. 3. FURNITURE, FIXTURES & BOOKS*, specifically *Item 3.I FURNITURE & FIXTURES*, with Code Nos. 2024-FFX-0005 (*Table, Senior Executive*), 2024-FFX-0006 (*Table, Clerical*), 2024-FFX-0008 (*Chair, Clerical*), and 2024-FFX-0009 (*Chair, Visitor*), and mode of procurement of Negotiated Procurement-Small Value Procurement (*NP-SVP*);

WHEREAS, Sections 53 and 53.9 of *The 2016 Revised Implementing Rules and Regulations* (Revised IRR) of Republic Act (R.A.) No. 9184, provide:

**Section 53. Negotiated Procurement.**

Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects and Consulting services, whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in any of the following cases:

...  
53.9 *Small Value Procurement.* Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR: *Provided*, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR.

**WHEREAS**, No. V (D) (8) of Annex "H" of the *Consolidated Guidelines for the Alternatives Methods of Procurement* of the Revised IRR provides:

**8. SMALL VALUE PROCUREMENT (SVP)**

**a) Definition.** Procurement of (a) goods not covered by Shopping under Section 52 of the IRR of RA 9184, (b) infrastructure projects, and (c) consulting services, where the amount involved does not exceed the following threshold:

- i. For NGAs, GOCCs, GFIs, SUCs, and Autonomous Regional Government, One Million Pesos (₱ 1,000,000) ...

**WHEREAS**, the amount involved in this procurement does not exceed ₱1,000,000.00.


**NOW, THEREFORE**, pursuant to the relevant provisions of R.A. No. 9184 and its Revised IRR, it is hereby **RECOMMENDED** that the **Alternative Method of Procurement** through **Negotiated Procurement**, specifically **Small Value Procurement** under Sections 53 and 53.9 of the Revised IRR, be undertaken in the procurement of the aforesaid services.






