THIS CONTRACT OF AGREEMENT made and entered into, by and between:

OFFICE OF THE OMBUDSMAN, AREA OFFICE FOR THE VISAYAS, FIELD OFFICE NO. VI, ILOILO CITY, with office address at 2nd Floor CAP Building, Gen. Luna Street, Iloilo City, represented by **DANTE F. VARGAS**, Deputy Ombudsman for the Visayas, hereinafter called "the ENTITY;"

-AND-

ILOILO CAR CORPORATION, with business address at Mc Arthur Drive, Brgy. Quintin Salas, Jaro, Iloilo City, represented by **Ms. BIANCA CAMILLE DOLLENTE**, Authorized Representative, hereinafter called "the SUPPLIER."

WHEREAS, the Entity, through the Bids and Awards Committee (BAC) of the Office of the Ombudsman, Area Office for Visayas, Field Office No. VI (OMB-VIS, FO6), invited Bids for certain goods and ancillary services, viz: ONE (1) UNIT BRAND NEW 2024 COMMUTER VAN for OMB-VIS FO6;

WHEREAS, the Entity, after the conduct of an open competitive bidding by the BAC of OMB-VIS FO6 pursuant to the provisions of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, awarded the contract to the Supplier, after finding that its proposal is the Single Calculated and Responsive Bid (SCRB) for the supply of **ONE (1) UNIT BRAND NEW 2024 COMMUTER VAN** in the sum of **ONE MILLION EIGHT HUNDRED NINETY-FIVE THOUSAND PESOS (₱1,895,000.00)**, hereinafter called the "Contract Price."

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as integral part of this Agreement, viz:

- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted, including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security

- d. Notice of Award; and the Bidder's conforme thereto; and

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract and in accordance with its Bid.
 4. The **OFFICE OF THE OMBUDSMAN, AREA OFFICE FOR THE VISAYAS, FIELD OFFICE NO. VI** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
